In response to many unit requests for a listing of distinguished individuals and organizations who have sent certificates of congratulations, this listing will help enhance a unit's Eagle ceremony with appropriate letters upon advance request. When requesting these letters, please provide the addressee with the following information:

1. Eagle candidate's full name (spelled correctly)
2. Unit number and chartered organization's name
3. Date candidate completed his Eagle Board of Review
4. Date of Eagle ceremony
5. Address where to send the letter or certificate
6. Telephone number of requesting individual

Please send your request at least four to six weeks prior to the Eagle Court of Honor date to allow sufficient time for response. We have noted that many requests sent two weeks prior to the ceremony did not arrive on time or the congratulatory either was never sent because it would not have been received in time.

Due to diverse geographical areas in the council, we could not provide a listing of all city or county councilmen, state delegates or state senators. Depending on where the Eagle resides, it is up to the unit representative to research and contact the appropriate representative. This should also include the Eagle candidate's congressman in the U. S. House of Representatives.
